

Amish Quilting Designs

1868-1962

A Visual Essay by Linda Baumgarten





Amish quilts have long graced gallery walls and inspired scholarly and often visually sumptuous publications. The quilts are known for bold piecing using solid textiles and rich colors. The quilting stitches, however, are far less obvious and more difficult to document, study, and compare. The purpose of this "visual essay" is to reveal Amish quilting patterns through line drawings of the stitching found in 82 Amish quilts dating from 1868 to 1962.

Introduction

Amish People and their Quilts

Scores of scholarly articles and books have told the history of the Amish peoples, first in Europe and then in America. The Amish follow the Christian denomination that had its origins in the Protestant Reformation of the 1500s and 1600s, especially in some areas of Germany and German-speaking regions of Switzerland and France. The group believed in adult—not infant—baptism and separation of church and state. The movement went through a number of schisms, and those who followed leader Jakob Ammann (1644–1730) became known as the Amish. Members began immigrating to America by the mid-eighteenth century, settling first in Pennsylvania and then eventually spreading west into Ohio, Indiana, Iowa, Illinois, Kansas, and Wisconsin.¹

Distinguished scholar Janneken Smucker has stated, "Despite much speculation, there is no coherent narrative that explains the development of quiltmaking among the Amish....Simply stated, no study has drawn on enough dated examples of quilts to document credibly when, where, or why Amish quiltmaking began."²

What is known is that Amish women began quilting relatively late in the history of American bedcovers—sometime during the second half of the nineteenth century—and the practice didn't become widespread until the late nineteenth century.³ Surviving quilts and longstanding scholarship reveal that most Amish women historically selected unpatterned textiles, often of dark or saturated colors, to create quilts using the piecing technique. Although they typically were slow to adopt the newest trends, Amish quilters were not a monolithic group; their products reflect regional variations and changes over time as quilters gradually responded to outside influences, textile availability, and new design and color trends.⁴

Originally made for close family and friends, Amish quilts became valuable outside the Amish community because the solid-colored textiles combined with bold piecing seemed to resemble dramatic pieces of abstract art when first hung on gallery walls. Scholars and collectors compared Pennsylvania Center Diamond and Framed quilts with abstract paintings by artists such as Josef Albers and Frank Stella. By the third quarter of the twentieth century, Amish quilts resonated positively with an audience increasingly familiar with modern abstract art.

Amish Quilting Motifs

Despite the wealth of scholarship, one aspect of Amish quilts has not been as thoroughly explored or published: the quilting itself.⁵ Colorful piecing is much easier to see and capture in photographs than the less obviously visible stitching that holds the layers together. In fact, the intricate stitching patterns sometimes appear to belie the apparent abstraction of the piecing (see cover illustration). This study presents a Catalog of 82 drawings that highlight the quilting motifs in bedcovers made by American Amish people. In the drawings, the quilting is shown as a series of thin black lines and the piecing in red lines. In the small-scale overall thumbnails, red lines indicate where the colors change, but do not necessarily include every piecing seam. If a pattern is a repeat, only a section of the piecing may be shown to suggest the pattern. Some of the drawings may have slight inaccuracies or parallax distortions, depending on the quality of this author's sketches and photographs from which the drawings were created.

Special attention is paid to quilts with known dates, since these examples are important steppingstones to understanding the use and genesis of specific designs. This study includes drawings of 37 quilts on which dates are inscribed. Those dated quilts are listed first, numbers 1 through 37, arranged in date order from 1868 to 1951.

Initials, when present, do not necessarily refer to the maker of the quilt, but may indicate the beneficiary of a gift. The quilter was known to her intimates and recipients and probably could not foresee a time when museums and authors would be searching for her identity.

Judging by the 82 quilts drawn for this study, as well as other known quilts that are not yet drawn, general trends are evident in Amish examples from the 1860s to the early 1960s. Amish quilts typically have wide borders on all four sides, which serve as

canvases for various quilted motifs including cables, feathers, fiddlehead ferns, and abstract baskets, (see Appendix A–E). Simpler borders may have repeated multiline fans or angled parallel lines. Center fields sometimes feature concentric stars and large feather wreaths (Appendix F). Smaller feathered circles or wreaths are also used as fillers (Appendix G).

Regional variations are evident in Amish quilting (Appendix H). Especially in Pennsylvania, flowers often include simplified tulips, twining vines in borders, or sprays of roses and tulips that fill large, pieced triangles. In quilts from Ohio, Indiana and other areas sometimes grouped together as the "Midwest," repeated pieced designs are especially popular, in which case the stitching either follows the outlines of the piecing or overlays the piecing with parallel straight lines or grids. In common with Pennsylvania, quilts from the Midwest often incorporate feather borders and circles.

Variations of feathers are the most popular motifs in the 82 quilts sampled here. Feather circles and wreaths are used in about 43% of quilts (Appendix F–G), while running feather vines, often curving gracefully inside the wide Amish quilt borders, also appear in about 43% of quilts (Appendix B–C). Variations of cables are found in about 39% of the quilts (Appendix A), and tulips appear in about 28% of the 82 quilts. See the index of designs at the end to identify additional specific motifs.

Influences




Fig. 1, A–C. Drawings comparing Center Diamond quilts by Welsh makers (A–B) and a Pennsylvania Amish maker (C). A. Unidentified quilter, Wales, United Kingdom, signed HG and dated 1818, silks and cottons, International Quilt Museum, Ardis and Robert James Collection, 2006.043.0063; B. Unidentified quilter, Wales, United Kingdom, 1890–1910, wools, International Quilt Museum, Gift of the Robert and Ardis James Foundation, 2005.058.0002; C. Unidentified Amish quilter, Lancaster County, Pennsylvania, signed AB and dated 1914, wools, International Quilt Museum, gift of Clyde E. and Joan B. Shorey, 2006.056.0001, see Catalog no. 17.

British scholar Dorothy Osler has argued that Welsh quilts may have influenced those made by Amish women, especially in Pennsylvania and Ohio, where Osler has documented communities of Welsh immigrants living close by Amish settlers.⁷ It is true that the Center Diamond piecing pattern does appear in both Welsh and Amish quilts (fig. 1 A–C).

However, variations of the Center Diamond design can also be found on bed covers made in the United Kingdom, the American colonies, and in the later states, dating from the eighteenth and nineteenth centuries.⁸ As for stitching, Welsh quilting makes heavy use of tight spirals and dense patterns unlike the typical designs found in Amish examples. Amish and Welsh quilts may share similarities in piecing and material choices, but, for the most part, the makers diverged in their choice of quilting motifs.⁹

The motifs used most often in Amish quilting, including feather variations and cables, were not unique to the Amish. Cables can be traced back in time to ancient Rome and continued in popularity on European and American decorative arts—including bed covers—to the present. Similarly, feathers are found on non-Amish bed quilts and women's quilted petticoats, or skirts, of the eighteenth and nineteenth centuries, and the well-established motif never went entirely out of use. ¹⁰ Amish quilters probably observed the bedcovers, clothing, and furnishings of their close non-Amish neighbors, and adapted motifs and styles to their own bed quilts, typically at a somewhat later date.

Comparisons: Two 1860s Quilts




Fig. 2A–B. Drawings of two wholecloth quilts probably by the same quilter or designer. A. Unidentified Amish maker, possibly Pennsylvania, signed GD and dated 1869, cottons, Indiana State Museum and Historic Sites, David Pottinger Collection of Indiana Amish Quilts, 71.989.001.0423, see Catalog no. 2; B. Unidentified Amish maker, possibly Pennsylvania, signed SD and dated 1868, wools, International Quilt Museum, gift of David Wheatcroft and Eve Wheatcroft Granick, 2005.055.0001, see Catalog no. 1.

Drawings like those presented in the Catalog make it easier to compare quilts from different collections and varying regions. Every surviving guilt is the by-product of a human story set within a larger community, making such comparisons especially valuable. A quilt can potentially speak of the environment and imagination of the woman who conceived it, the family and friends who may have helped her design or stitch it, and perhaps the loved one who received it. Some quilts may be signed, dated, or accompanied by family history. Such is the case with a blue cotton wholecloth quilt in the collections of the Indiana State Museum, signed and dated in the stitching, "GD 1869" (fig. 2A and Catalog no. 2). The quilt features an all-over double-line grid in the center field bordered by seven-line cables and eight-pointed stars in each of the four corners.


In 1989 Eve Wheatcroft Granick wrote that the quilt "was brought to Indiana by an Amish family who originated in Lancaster County, where the quilt was likely made." Granick does not footnote the source for the statement, although perhaps the information came from family history related

personally to the author or collector. The museum's object files state that the quilt was obtained from the David Pottinger Collection of Indiana Amish Quilts.¹²

With the benefit of line drawings for easy comparison of the quilting motifs, it becomes clear that the 1869 guilt is closely related to another wholecloth example dated one year earlier, now in the collections of the International Quilt Museum (fig. 2B and Catalog no. 1). Constructed of dark blue wool, the second quilt survives as two fragments. The quilt has a center field partitioned into three parts, with overlapping circles ("Orange Peel") in the middle and double-line grids in the two adjacent panels. Like the 1869 guilt, the borders are filled with seven-line cables with eight-pointed stars in the four corners. One corner carries the stitched-in signature "SD 1868." The quilt was obtained from collector and scholar David Wheatcroft, who attributed it to Lancaster County, Pennsylvania. Wheatcroft had purchased the quilt from an Amish man who bought and sold quilts, although Wheatcroft was not able to learn where the original Amish dealer or collector purchased it.13

The quilting similarities suggest that the two examples were probably drawn by the same individual or that they originated in the same family—but where and who? Was Granick's information correct that the 1869 example was brought to Indiana from Lancaster County, Pennsylvania—or could it have been made in Indiana? Comparisons of the stitching with other quilts in the Catalog are suggestive but not definitive. Although double-line eight-pointed stars are used in Pennsylvania Amish quilts (see Catalog nos. 8, 23, and 35), they are not unique to the Amish. The interwoven multiline cable appears in Pennsylvania in a 3-line version (Catalog nos. 14 and 62) and in Indiana or Ohio and Illinois in 5-line versions (Catalog nos. 29 and 42). The closest cable design, a similarly elongated 6-line cable, occurs in an Indiana quilt dated 1925 (Catalog no. 22) more than 50 years later. Until additional comparative examples with credible histories can be found, the origins of the two quilts will likely remain speculative.



Comparisons: The Compote Group




Fig. 3 A–B. Detail sections of two Center Diamond quilts showing similarity of quilting pattern and the use of a compote of fruit in the corners. A. Mattie King Stoltzfus and daughter Lydia Stoltzfus (later Mrs. David Renno), Lancaster County, Pennsylvania, probably ca. 1941, wool, International Quilt Museum, Ardis and Robert James Collection, 1997.007.0220, see Catalog no. 55; B. Unknown quilter, Lancaster County, Pennsylvania, 1915–1940, wools, Lancaster History, Heritage Center Collection, Esprit Quilt Collection, P.02.51.11, see Catalog no. 54.

Drawings of Amish quilting patterns can also suggest connections and design sources that were previously unrecognized (figs. 3A-B). According to the family story, Mattie King Stoltzfus (1893-1971) of Lancaster County, Pennsylvania, created a Center Diamond quilt with the help of her daughter Lydia (1918–2003) (fig. 3A and Catalog no. 55). Although the quilt is not dated on the piece, tradition holds that daughter Lydia received it at the time of her marriage to David Renno in 1941.14 The center is filled with concentric six-pointed stars enclosed by a feathered wreath, with two different sizes of branching flower sprays placed outside the wreath. The narrow inner borders have repeated four-petal flowers within squares on point, and the wide outside borders are embellished with S-curved feather scrolls. It may

have been the atypical motif in the outer corners that caught the attention of collectors Ardis and Robert James: a realistically rendered footed bowl of fruit, or compote. According to a 1987 letter from the dealer Joe Sarah to Ardis James, the Amish daughter Lydia Stoltzfus Renno took credit for the compotes in the corners. Mr. Sarah states in his letter, "Mrs. Renno tells the story that it was she who came up with the idea for this motif and her mother told her that the quilt was going to be hers and that she could have it the way she wanted it. But, if the compote of flowers and fruit was her choice, she (i.e., the daughter) would have to do the quilting herself. Mrs. Stoltzfus said that she did not have time to do quilting of this complexity, but Mrs. Renno says that she has always felt that her mother was hesitant to fly in the face, if you will, of tradition or to test the acceptability of the practice in the Amish church. So, Mrs. Renno—

then Lydia Stoltzfus—quilted the urns in the corner blocks."¹⁵

Lydia may have chosen the fruit compotes or "urns" and quilted them herself, but she did not design them. Instead, the motif matches one on a hand towel used much earlier in the same Lancaster County Amish community. In 1915, an Amish woman named Rachel Smoker embroidered and signed a red on white hand towel with her initials "RS" and the phrase "From Aunt Rachel Smoker 1915," along with outline stitched calla lilies, two small vases of tulips, and a large footed bowl of fruit matching that on the quilt. The fruit bowl and other motifs on the towel probably came from commercially published patterns intended for the highly popular redwork outline embroidery. The structure of the highly popular redwork outline embroidery.

Adding complexity to the story is the fact that bride-to-be Lydia Stoltzfus' quilt was not the only one with the compote motif in the corner blocks: two additional quilts have similar compotes in the outer corners. The first of the two is in the collections of the Lancaster History Museum (fig. 3 B, Catalog no. 54). Not only does the quilt have fruit compotes in the corners, the quilting on the remainder of the bedcover is nearly identical: concentric stars inside a feathered wreath, rose and tulip sprays, four-petal flowers within squares on point, and feathered vines. Further, the two quilts are almost identical in size. 18 Although the maker of the Lancaster History Museum example is not known, the quilt must come from the same community—and possibly from the same designer, maker, or family. But are both quilts about the same date? After all, the embroidered towel with compote was dated 1915, three years before Lydia was born.




Fig. 4. Center Diamond quilt with compote of fruit angled in the corners. Unknown quilter, Lancaster County, Pennsylvania, dated 1914, location unknown, see Catalog no. 18.

A third quilt further complicates the question of date (fig. 4, Catalog no. 18). Formerly in the collections of The People's Place Museum in Intercourse, Pennsylvania, and now unlocated, the quilt has what appears to be the same bowl of fruit—now angled in the corners—and a similar center star within a feathered wreath. However, the feathered border is different, and a grid fills the quadrants outside the central diamond. This quilt is dated in the stitching "1914," one year earlier than the redwork towel and more than 25 years before Lydia Stoltzfus Renno and

her mother are believed to have finished the wedding quilt. Is Lydia's memory accurate that she quilted the compote as late as 1941, when she was about 23 years old? Who designed and quilted the second example that matches Lydia's quilt so closely, and did those quilters know about the much earlier 1914 example? Frustratingly, the answers are not yet clear. Perhaps drawings will help lead to future insights.

Summary

Although the piecing and stitching patterns suggest that Amish women were familiar with and probably influenced by the quilting of their non-Amish neighbors, the Amish typically adopted outside trends at a later date, after the styles were no longer the newest fashion. Janneken Smucker has termed this process "selective adaptation." Eve Wheatcroft Granick uses the phrase "interaction and avoidance" to describe the process of borrowing some features from outside the community while also avoiding styles that are judged incompatible with a conservative lifestyle. ²¹

Studying quilting designs and comparing similar examples underscores several important characteristics of Amish quilting. Many Amish women were not averse to using commercial patterns and pre-stamped textiles for some of their embroidered household linens, and they freely selected and adapted patterns from published sources for their quilting, as well.²² The compote motif, for example, almost

certainly originated in an outline embroidery pattern. Once a pattern was acquired or first used, Amish women did not hesitate to reuse it over many years; "brand new" was not necessarily "better." If the dating of the three compote quilts is accurate (see figs. 3 and 4), the motif was in use for more than a quarter century.

Amish women were conservative in their choice of design and sometimes returned to the same piecing and quilting designs (or they reused templates) over many years, making unsigned quilts difficult to date. As a group, the Amish tended to draw on the past; cables and feathers had been used for centuries before Amish women widely adopted (and adapted) them.

Amish quilters were not as isolated as might be assumed. And although Amish communities generally tended to avoid worldly influences, they were not monolithic; each community set its own standards for what was considered appropriate for their vehicles, farming practices, and household furnishings. Even within communities united by common religious traditions, regional variations and individual personalities are apparent. Isolating the quilting patterns by means of easily studied drawings may allow these regional differences and personal styles to emerge even more clearly in the future.










Roman Stripes Quilt Unidentified maker, marked "I. J. Y." and "F. E. H." Holmes County, Ohio, 1912







Center Diamond Quilt Probably Sarah Smoker Lancaster County, Pennsylvania, 1920-1935
